Subject: **ANNOUNCEMENT OF ELECTION SCHEDULE FOR ELECTION AGAINST TEN (10) VACANT SEATS OF CORPORATE MEMBERS, FIVE (05) VACANT SEATS OF ASSOCIATE MEMBERS AND TWO (02) SEATS RESERVED FOR WOMEN ENTREPRENEURS OF EXECUTIVE COMMITTEE OF CONSTRUCTORS ASSOCIATION OF PAKISTAN (CAP) FOR THE TERM 2017-2019.**

Sir,

1. This is to inform that Constructors Association of Pakistan (CAP) has been granted license No. 23 under the Trade Organizations Act, 2013. There are two types of members as per followings: -

a. Corporate Member:

"Corporate Member" means a member of a trade organization which is either a body corporate or a multinational corporation with its head office or branch office in Pakistan or a sales-tax registered manufacturing concern or a sales-tax-registered business concern having annual turn-over of Rs. 50 million or above;

b. Associate Member:

"Associate Member" means a member of a trade Organization which is not a body corporate or a multinational or a sales tax registered manufacturing concern or a sales-tax-registered business concern having annual turn-over of Rs. 50 million or above;

2. The Executive Committee of Constructors Association of Pakistan (CAP) in its 100th meeting held on Monday the 3rd July, 2017 in the Islamabad Hotel, Islamabad, under the chairmanship of Engr. Sikandar Hayat Khattak, Chairman CAP, decided that the total number of seats for the executive committee of CAP for the term 2017-2019 will be twenty-eight (28) with following breakup: -

- a) Sixteen (16) seats of Corporate Members.
- b) Ten (10) seats of Associate Members.
- c) Two (02) seats reserved for Women entrepreneurs.

According to the Trade Organization Rules, 2013, six (06) seats of Corporate Members and five (05) seats of Associate Members will continue for the year 2017-2019. That being the case election for electing the seventeen (17) vacant seats of executive committee of Constructors Association of Pakistan (CAP) for the term 2016-2018 will be held as per following: -

- a) Ten (10) vacant seats of Corporate Members.
 - b) Five (05) vacant seats of Associate Members, and
 - c) Two (02) vacant seats reserved for Women entrepreneurs.


