Subject: **ANNOUNCEMENT OF ELECTION SCHEDULE FOR CAP EXECUTIVE COMMITTEE FOR THE TERM 2021-23**

This is to inform that the Executive Committee of Constructors Association of Pakistan (CAP) in its 125th meeting held on Monday, July 05, 2021 at Islamabad, under the chairmanship of Engr, Syed Ashfaq Hussain, Chairman, CAP has decided that the total number of seats for the Executive Committee of CAP for the term 2021-2023 will be twenty-eight (28) with following breakup: -
