The election of one position of Chairman for one-year term 2022-2023 will be from Northern Zone comprising of Punjab, Khyber Pakhtunkhwa and Islamabad Capital Territory in terms of Order No. 5(2)/97.TO-1 dated 24th April, 1997, of Ministry of Commerce, Government of Pakistan, Islamabad, which is reproduced below: -

The term of office of the Managing Committee / Executive Committee and office bearers of the Association shall continue as per their Articles of Association. However, the office of Chairman / President of Association shall rotate between North & South zones, wherever the Associations have such zone as per their Articles & Memorandum.

The procedure for filing the nomination paper is that Executive Committee Member who want to contest election for the position of Chairman, Senior Vice Chairman and Provincial Chairmen, will sign the nomination paper and have it proposed and seconded by the Executive Committee Members and send it to CAP office, Lahore by September 15, 2022 upto 5:00 PM. Last date for withdrawal of nomination papers is September 16, 2022 upto 05:00 PM.
6. ***The election for office bearers will take place on Saturday, September 17, 2022 from 09.00 AM to 05:00 PM at the CAP Secretariat situated at 2nd Floor, Classic Complex, 35-M, Model Town Extension, Lahore.***
