This is to inform that the Executive Committee of Constructors Association of Pakistan (CAP) in its 134th Meeting held on Thursday, July 13, 2023 at Islamabad, under the chairmanship of Engr. Syed Ashafq Hussain, Chairman, CAP has decided that the total number of seats for the Executive Committee of CAP for the term 2023-2025 will be twenty-eight (28) with following breakup: -
