CAP - ANNUAL THREE YEARS PERFORMANCE REVIEW FOR THE YEARS ENDED JUNE 2016, 2017 & 2018

This is in accordance with the requirements of Trade Organizations Act 2013 and Trade Organizations Rule 23(2) Annual Performance Review against the "three years plan of activities" duly approved by the Executive Committee dated December 14, 2018 for submission to the office of the Director General, Trade Organizations (DGTO), Government of Pakistan, Islamabad, as carried out by our firm and reported as under:

- 1. After a series of Meetings with Pakistan Engineering Council (PEC), the CAP help desk was established at the Head Quarter and the Provincial Offices of PEC. It will facilitate the issuance of the new license as well as renewal of existing PEC Licenses for the Construction Companies.
- 2. Issue for the import of used Specialized Construction, Off Highway, Vehicle mounted construction machinery and Transport equipment was taken with Ministry of Commerce, Engineering Development Board and Ministry of Industries for permission to allow construction machinery not older than 15 years.
- 3. Meetings held with Minister of Planning and Minister of Finance to improve financing for construction and housing projects.
- 4. Efforts have been made to replace bank guarantees with AA rating insurance guarantees. Yet actions are underway.
- 5. Association actively perusing resolution of disputes through ADR.
- 6. Due to economic situation and terrorism wave, the international business scenario in the Middle East has been under turmoil which led to slow proceeding in the industry.
- 7. Association continues to seek the reduction in duties and sales tax on the construction machinery not manufactured in Pakistan or being imported in Pakistan.

- 8. Both government and Association working together to create one window facilitation centre for construction industry and independent construction industry authority has been suggested.
- 9. CAP is active and seeking affiliation with all relevant forums.
- 10. Follow up continue to get free land for Construction of CAP office at Islamabad.

PERFORMANCE FOR THE FINANCIAL YEAR ENDING JUNE 2016

- 1. The Association by complying with the Trade Laws and rules had conducted election 2016 and peacefully handed over the power to the elected representatives.
- 2. The Association had strived to maintain its membership level and sent necessary renewal notices and reminders for renewal of membership. 8 new Members were also enrolled during the year 2016.
- 3. Annual General Meeting of the Association was held in compliance with the Law and Memorandum of Articles of Association.
- 4. Share From the CPEC Projects: A series of Meetings were held with the Chairman, National Highway Authority (NHA) and Minister for Planning, Development and Reforms (PD&R) to allocate share in development and infrastructure Projects to the local constructors especially from the CPEC projects.
- 5. Al Hamd o Lillah, the Association was successful to get the **one contract** valuing over 25 Billion from CPEC western corridor.
- **6.** The limits of the Insurance companies were relatively low and local insurance companies were not able to provide required bonding because of the size of the CPEC projects.
- 7. CAP has advocated all the local insurance companies to take their share of business by increasing the bonding limits and exposure of risk at the earliest.
- 8. **Capacity Building** of the Local Construction Industry: Meetings with NHA were held to convince the Authorities for the Following:
- 9. **Qualification Criteria** –Collective experience of all partners for the last ten year may be considered and Nos. of experience years according to the quantity based on quantum of work may be considered while evaluation of projects.
- 10. **Contract Conditions:** Contract as per PEC Bidding Documents which is approved by ECNEC harmonized with PEPRA rules, Particularly as per Bidding Documents may be adopted. Following conditions were also agreed with NHA:

EMMac

a) Bid Bond from AA rated Insurance Companies.

b) Performance Guarantee from AA rated Insurance Company.

c) Mobilization Advance 15% from AA rated Insurance Company.

d) NHA should open L/C for import of equipment up-to 20% of Contract Value.

e) 30% of Local participation as per PEC guide line should be followed:

f) For GOP funded projects only local companies should be allowed to participate.

g) Capacity of Local construction sectors is withheld in the shape of Bond and cash. Following steps were suggested.

h) 20% of Performance Guarantees laying with NHA may be replaced with Insurance Guarantees. 80% Bond may be released.

i) Payments may be released as per Contract Conditions it should not be tied up with audit

j) PEC registered and CAP certified Contractors may be allowed duty and Sales Tax free Import of Machinery, Plant and Equipment.

- k) The members have participated actively in the Expo held at Lahore Expo Centre on Construction and Construction related material and services on 18th to 22nd March,
- l) Meetings with the PEC, NHA, FBR and other related departments held regularly to discuss and resolve the matters in the interest of Members and industry.
- m) Meeting was arranged with the Federal Ministers and authorities on issues of importance.

n) Capacity building events were attended by CAP members

- o) As reported by Association, due to slow down of economic activities as a result of law and order situation, energy shortage, hike in fuel prices the construction activities remained depressed and it leads to decrease in Membership of renewals.

q) CAP Executive Committee held 9 meetings and discussed construction industry issues which were partially resolved.

r) The Association has been in contact with the International market for best machinery on best prices. We have witnessed rise in quality international construction machinery especially roads, high rise buildings and industrial projects.

s) CAP arranged annual Dinner.

t) Association continuously pursued on PEC Standard Bidding Documents which have been improved, approved and implemented
