The Chairman informed that minutes of 25th Annual General Meeting (AGM-2022) held on September 24, 2022 at CAP Office, Islamabad, Lahore, Karachi & Peshawar through video link under the chairmanship of Engr. Chairman, CAP informed the members of AGM that accounts of Constructors Association of Pakistan (CAP) have been audited every year for keeping the transparency in day-to-day expenditure of the Association. So, the annual accounts of CAP for the year 2022-23 ended on June 30, 2023 have been audited by M/s. Aslam Malik & Company, Chartered Accountants, Lahore and the Auditor's report were placed in the meeting of Executive Committee held on August 12, 2023 at CAP Office, Islamabad under the Chairmanship of Engr. Syed Ashfaq Hussain, Chairman, CAP. The ECM has approved the Audit Report and recommended to place the same before the AGM for approval.

Ch. Naeem Akhtar proposed and Ch. Ahmad Habib seconded to adopt audited and accounts along with auditor's report for the fiscal year 2022-2023 of Constructors Association of Pakistan (CAP) for the fiscal year 2022-2023 and the AGM approved the same.

Syed Ashfaq Hussain, Chairman, CAP. The Executive Committee approved the appointment of M/s. Aslam Malik & Company, (Chartered Accountants), Lahore and recommend to place before the members of 26th Annual General Meeting (AGM-2023) to appoint M/s. Aslam Malik & Company, (Chartered Accountants), Lahore a QCR rated firm as Auditor for carrying out the audit of accounts and filing of tax returns of CAP for the year 2023-2024 at an Annual remuneration of Rs.60,000/-.

Ch. Ahmad Habib proposed and Ch. Khaleeq Ahmad Awan seconded for approval of appointment of M/s. Aslam Malik & Company, (Chartered Accountants), Lahore as an Auditors for carrying out the audit of accounts and filing of tax returns of CAP for financial year 2023-2024 at a remuneration of Rs.60,000/- (Rupees sixty thousand only).



#### **DECISION:**

The AGM-2023 approved the appointment of M/s. Aslam Malik & Company, (Chartered Accountants), Lahore as Auditors for carrying out the audit of accounts and filing of tax returns of CAP for the financial year 2023-2024 at an annual fee of Rs.60,000/- (Rupees sixty thousand only).

## **AGENDA ITEM NO 05:**

To approve Annual Report for the year 2022-2023.

In accordance with Article-78 of Memorandum and Articles of Association of CAP, CAP has to place an Annual Report of the work done and the progress made by the Association during the tenure of office bearers before the AGM after the approval of the Executive Committee. The agenda was considered in the 135th meeting of Executive Committee held on August 12, 2023 at CAP Office, Islamabad, under the Chairmanship of Engr. Syed Ashfaq Hussain, Chairman, CAP and approved / recommend to place the Annual Report of the work done and the progress made by the Association during the tenure of office bearers before the Annual General Meeting along with Annual Report for the year 2022-2023 for approval.

Ch. Ahmad Habib proposed and Ch. Naeem Akhtar seconded for approval of Annual Report for the year 2022-2023 by the AGM.

### Address by Engr. Syed Ashfaq Hussain

Engr. Syed Ashfaq Hussain, Chairman CAP thanked the participants for their participation and specifically thanked to Engr. Arshad Dad, Chief Advisor CAP and Engr. Khalid Bashir, CEO, M/s Zirva (Pvt) Limited, Islamabad for their proficient involvement with the Association and said that I belief that they should play their energetic role in upcoming election of PEC effectively as he did in 2021 and preparation in the matter should be started instantaneously. Chairman, CAP stated that many crucial issues of constructors have been resolved and some are near to be resolved with the cooperation of present Chairman PEC. However, some important issues like establishment of CIDB are still pending in the PEC and constructors need the support of the upcoming Chairman PEC, to resolve the same pleasantly. Although discussing the agenda, he apprehended that if the Chairman



PEC is elected without the support of the CAP, then its result would be different as of today. He also suggested that members of the CAP should awake at the earliest and prepare themselves for PEC election 2024 with coordinated efforts. Chairman proposed that Central Election Cell will be maintained at CAP Office Islamabad under the guidelines and suggestions of Engr. Khalid Bashir, Engr Arshad Dad and other senior members of CAP. The Provincial cells of PEC Election-2024 will be retained at CAP Office Lahore, Karachi, Peshawar, Quetta, Gilgit Baltistan and AJK. The Chairman CAP further specified that my expectations are still same upon the Chief/District Coordinators and other CAP members as was in the previous Election-2021. All the members of CAP and office bearers at Provincial, Divisional and District level should be ready for work hard to win the PEC Election-2024. He also suggested that the campaign for raising the funds may also be initiated at once as was launched in the previous PEC election, 2021 by the members of CAP.
