It is hereby informed that the Executive Committee of the Constructors Association of Pakistan (CAP), in its 144th Meeting held on Monday, July 13, 2026, at the CAP Office, Islamabad, under the chairmanship of Syed Afzal-Ur-Rahman, Chairman, CAP, has approved the announcement of elections for the Executive Committee of the Association for the term 2026–2028.

SATURDAY JUNE 04, 2026	Notice for holding Executive Committee meeting to be held on Monday, July 13, 2026.
MONDAY JULY 13, 2026	Holding of Executive Committee meeting for approval of election schedule.
WEDNESDAY JULY 15, 2026	Last date for announcement of election schedule and appointment of election commission for display: a) at the notice board at head office of CAP; b) at the website of CAP; and c) Submitted to the Regulator.
SATURDAY JULY 18, 2026	Start receiving nomination papers (July 18 to August 24, 2026) . Receipt of Nomination Paper from the consenting members (duly proposed and seconded by a registered voter and to be signed by the candidate).
TUESDAY JULY 21, 2026	Last date for intimation by member firms desiring to change their representative i.e. name of representative to the Secretary General along with necessary proof of eligibility.
FRIDAY JULY 24, 2026	Last date for display of provisional list of voters eligible to vote along with their national tax number, sales tax registration number, if applicable, the name and national identity card number of their representative) on: a) Notice Board at head office; b) Website of CAP
MONDAY AUGUST 03, 2026	Last date for receipt of any objection by the members to the entries in the list of voters. (Members shall send their objections in writing to the Secretary General).
THURSDAY AUGUST 06, 2026	Last date by which the Secretary General will intimate action on the objections or changes sent by member.
SATURDAY AUGUST 08, 2026	Last date for making representation to the election commission by the members aggrieved by the decision of Secretary General.
TUESDAY AUGUST 11, 2026	Last date for making appeal to the Regulator by the members aggrieved by the decision of election commission. Regulator shall decide the case within 10 days and his decision in this regard shall be final.

SATURDAY AUGUST 22, 2026	Last date for displaying final list of voters: a) at the notice board at head office of CAP; b) at the website of CAP; and c) Submission to the Regulator.
MONDAY AUGUST 24, 2026	Last date for receipt of Nomination Papers for EC Members, up to 05:00 PM.
TUESDAY AUGUST 25, 2026	Last date for scrutiny of nomination papers by the election commission and issuance of provisional list of eligible candidates and provision of final list of voters to each eligible candidate.
WEDNESDAY AUGUST 26, 2026	Last date for receipt of objections, if any, to the nomination of candidates/filing of withdrawal application from elections of Executive Committee by contesting candidate.
SATURDAY AUGUST 29, 2026	Last date by which election commission will finalize objection / withdrawal applications.
MONDAY AUGUST 31, 2026	Last date for filing of appeal with Regulator by the Member aggrieved by the decision of election commission.
SATURDAY SEPTEMBER 05, 2026	Last date for receipt of decision of Regulator.
TUESDAY SEPTEMBER 08, 2026	Last date for issuance of final list of candidates.
